Of the Court of Appeal of The United States Auto Club 02 October 2023

Appeal lodged by Mr. Raphael Hess RH Race Engineering / ST Racing Entrant #38

Against the Steward's Decision GT3-06
Arising from Post Race Technical Inspection
Sebring International Raceway, Sebring Florida
24 September 2023

The Court of Appeal Comprised of:

Chair: Mr. Jason Smith, USAC Sr. Vice President of Competition

Decision Outcome:

The court denies the appeal and upholds the Steward's Decision (GT3-06) regarding the penalty for car 38/ST Racing.

Regulatory Reference:

The decision is <u>not</u> based on the 2023 SRO GT World Challenge Sporting Regulations 18.3, which initially states that protests will not be permitted for scrutineering inspections.

Appeal Proceeding:

The Appellate court allowed the appeal to proceed based on the FIA International Sporting Code - Article 15.

Findings and Submissions:

The court reviewed submissions provided by ST Racing but determined that findings driven by team data supplied were uncontrolled by SRO were unofficial and couldn't support the appeal.

Technical Violation:

Post-race technical inspection found that Car #38 was outside the boost limits outlined in the 2023 SRO Technical Regulations. And Balance of Performance Tables for Sebring by the SRO GT Bureau 08/09/2023

Official Measurement Tools:

The measurement tools used by the series are considered official, and results derived from their use are considered the only official results as per SRO Regulations.

Addendum Disregarded:

An addendum provided to the court on October 3, 2023, was deemed irrelevant to the proceeding.

Court Recommendations to SRO:

The court made recommendations to SRO for consideration:

- Documenting all communication between Series Officials and teams or manufacturers.
- Adopting a redundant strategy for critical measurements, especially those involving sensors.

Determination Regarding Admissibility:

The court found that the appeal was admissible, confirming the appellant's standing, timely submission of the appeal form, and timely submission of the appeal fee.

In summary, the court upheld the Steward's Decision based on the technical violation findings and clarified the admissibility of the appeal, while also providing recommendations for future considerations by SRO.
